A. CALL TO ORDER AND REVIEW OF PUBLIC COMMENT GUIDELINES

Lisa Kirvin called the meeting to order and reviewed the public comment guidelines.

Lisa Kirvin introduced the board and staff to the members of the public present.

C. APPROVAL OF MINUTES

D. REPORT ON CONFLICTS OF INTEREST

There were no conflicts of interest to report.

E. DISCUSS PLANNED BOARD AND COMMITTEE MEETING SCHEDULE FOR 2023

Lisa Kirvin shared a draft schedule for YBCBD committee and board meetings in 2023, which includes five (5) board meetings a year and seven (7) Executive Committee meetings during the alternating months. Other committees will meet on a quarterly basis throughout the year.

Lisa informed that beginning in March, all committee and board meetings will be held in-person with a Zoom option available upon request.

Lisa shared a memo from legal counsel detailing requirements for remote meeting attendance from board and committee members.

There was no public comment on this item.

I. HIGHLIGHT 2022 ACCOMPLISHMENTS AND PRELIMINARY PLANS FOR 2023

H-1 RECEIVE UPDATE from Streets Committee.

Tom Maguire reported on the Streets Committee's accomplishments in 2022:

- Supported three (3) new public art installations in the neighborhood
- Launched free public art walking tour
- Celebrated opening of Yerba Buena/Moscone MUNI subway stop

Tom informed that in the coming year, the committee plans to complete the Dog Spot project, which will be a designated pet relief area located at 3rd and Folsom Streets.

There was no public comment on this item.

H-2 RECEIVE UPDATE from Services Committee.

Katharine Greenbaum reported on the Services Committee's accomplishments in 2022:

- Ongoing Clean Team and Community Guide field work in the neighborhood including street cleaning, graffiti abatement, and wellness checks on unhoused residents
- Acquired new steam cleaning equipment to improve existing pressure washing services
- Updated format of monthly Services reports to be more accessible to the public
- Increased cleaning services on 3rd and 4th Streets with funds from the Clean California grant

Katharine informed that in the coming year, the committee plans to continue discussions about training field staff to carry Naloxone (Narcan) to aid in overdose prevention, which will also be brought before the Board later in the year.

There was no public comment on this item.

H-3 RECEIVE UPDATE from Marketing Committee.

Rachel Gordon reported on the Marketing Committee's accomplishments in 2022:

- Hosted the 2022 Yerba Buena Community Excellence Awards
- Released several new promotional videos for the neighborhood
- Produced a pilot Yerba Buena Art and Maker's Market in Yerba Buena Gardens
- Participated in Sunday Streets Festival, in partnership with Livable Cities and a number of neighborhood businesses
- Hosted a District 6 Candidate Forum in partnership with the Yerba Buena Gardens Conservancy
- Launched ARTober Festival as a monthlong promotion for neighborhood museums and galleries
- Produced the 10th and final Yerba Buena Night festival

Rachel informed that in the coming year, the committee plans to hold a strategic planning session on neighborhood branding and produce nine (9) monthly Art Markets in Yerba Buena Gardens with funding from the Office of Economic and Workforce Development.

There was no public comment on this item.

H-4 RECEIVE UPDATE from Community Benefit Fund Committee.

Nate Savalza announced that in 2022, the Community Benefit Fund Committee funded 14 organizations through 18 full and mini-grants, totaling \$159,000 in funding given to nonprofits in Yerba Buena.

Nate informed that there will two grant cycles in 2023, one in the spring and one in the fall, with a total of \$166,000 budgeted for grant funding throughout the year. The first round was recently opened with grants due in February, reviewed in March, and announced in April.

Richard Ciccarone shared a video highlighting the YBCBD's organizational accomplishments in 2022.
